



Terms of Use and Liability Waiver

We want The Cool Cafe' to be a place of relaxed enjoyment, fun, and social connection! In light of this we know more fun and enjoyment will be had by all when our patrons follow our guidelines and policies.

Liability Waiver:

Patrons entering The Cool Cafe' acknowledge the inherent risks present in an indoor play environment. While The Cool Cafe' works diligently to provide a safe environment for all, certain risks, whether inherent in the facility itself or caused by the actions of other patrons, are unavoidable. By using our facility, Patrons shall indemnify The Cool Cafe' its employees, volunteers, agents and officers against any and all liability incurred by any negligent or willful act of the patron, caregiver, child, or other patrons. A complete copy of this Terms of Use and Liability Waiver is posted at the Cafe and is also available upon request from any team member.

Terms of Use:

The Cool Cafe' reserves the right to refuse service to any Patron whose presence detracts from the safety, welfare, and well-being of other Patrons and the Cafe itself. The Cool Cafe' reserves the right to amend these Terms of Use and Liability Waiver at any time.

The Cool Cafe':

Respect and kind manners are always expected of everyone in the Cafe'.

Children and adults will be kind, respectful, and conscious of the safety of all patrons. Rough play nor bullying will not be tolerated.

Those unable to comply will be asked to leave the premises. They will not be allowed back in the Cafe' for the rest of the day. They will not be allowed to come back to the cafe' until they have spoken with a supervisor at the Cafe' and they have been granted permission to return.

All children and adults will play and behave according to the posted rules. Toys are for home. Safety is our highest priority, so no outside toys such as nerf guns, toy guns, balls, rackets, etc. are allowed to be played with at the Cafe'.



Food is for the Cafe. It is best if food is eaten in the cafe and not taken into the play space. Food needs to be eaten at the tables and drinks should not be carried around or left to rest on the furniture or games.

Cool Café Rules

1. ***Be kind***
2. ***Keep shoes on***
3. ***Eat at table or counter***
4. ***Clean up mess if you spill & tell staff***
5. ***Place trash in garbage***
6. ***Recycle plastic, cans & glass***
7. ***Treat furniture with respect***
8. ***Keep out of entryway***
9. ***Spread positivity***

The Cool Cafe' Policies:

Parents are invited to play and stay at the cafe while their children are present:

Age 5 or younger require a parent or an adult to supervise them in the cafe. Children and adolescents must follow the rules of the cafe and staff and respect staff reinforcement. Two unheeded warnings will result in a conversation with the child and/or parent and encouragement to take a break from the cafe. The Cool Cafe' reserves the right to deny access to children who choose not to comply by our guidelines.

Our Safety Rules:

No running in the playground. Please watch for little ones and be respectful.

No climbing on the furniture.

No playing outside near the street, in the street or running towards the street. Children need to remain in the Cafe'.

Children need to sign in and out of the Cafe' every time they enter and exit.

LIABILITY WAIVER AND RELEASE FORM (MINOR CHILD)

THIS IS A RELEASE OF LEGAL RIGHTS – READ AND UNDERSTAND BEFORE SIGNING

I hereby certify that I am the adult parent or guardian of _____, a minor child under the age of eighteen years, and I consent to his/her participation in recreational activities at The Cool Cafe' and accept full responsibility for the child to participate in the activities operated and maintained by staff and volunteers of RISE nonprofit.

I understand and acknowledge that I am fully aware of and assume the risks (including but not limited to the risk of serious bodily injury, property loss or damage) of (1) said minor child' s participation in recreational activities. I understand that The Cool Cafe' will always have an adult supervisor on site but that they are not responsible. I am solely responsible for the decision to allow my/the child to participate and attend recreational fun at The Cool Cafe'. I recognize my responsibility to ensure that said minor child participates and attends The Cool Cafe' only if I believe that the child is responsible in a setting with multiple children and adolescents of all ages. I understand that The Cool Cafe' shall have no responsibility to pay for medical treatment and related costs if said minor child is injured.

Knowing the risks described above, I agree, personally and on behalf of the minor child named above, to assume all the risks and responsibilities surrounding my minor child' s use of the The Cool Cafe'. To the fullest extent allowed by law, I hold harmless and agree to indemnify The Cool Cafe', its officers, directors, faculty, staff, volunteers, employees and agents, from and against any present or future claim, cause of action, loss or liability for injury to person or property, which said minor child may suffer or for which said minor child may be liable to any other person, related to said minor child' s participation in recreational activities at The Cool Cafe', resulting from any cause whatsoever, and regardless of fault.

I am at least eighteen years of age and mental competence to knowingly and carefully have read and freely signed this Liability Waiver and Release Form (Minor Child). I understand and agree that no oral or written representations can or will alter the contents of this document. I agree that this agreement shall be governed by the laws of the Commonwealth of Montana (excluding its conflict of laws principles).

I HERBEY RELEASE AND WAIVE, ANY AND ALL CLAIMS , KNOWN AND UNKNOWN, THAT THE CHILD/CHILDREN OR I MAY NOW OR LATER HAVE AGAINST THE COOL CAFE', ITS MEMBER(S), OFFICER(S), INSTRUCTOR(S), OPERATOR(S) AGENTS, VOLUNTEERS OR REPRESENTATIVES RELATED TO ANY ACT, OMISSION, STATEMENT, OR OCCURRENCE DURING OR RELATED TO THE USE OF THE COOL CAFE' OR THE FACILITY, FOR , LIABILITY FOR DIRECT, INDIRECT, VICARIOUS, PUNITIVE AND ANY OTHER DAMAGE WHETHER SUCH PARTY WAS INFORMED OR WAS AWARE OF THE POSSIBILITY OF SUCH LOSS OR DAMAGE.
